**Biographical Sketch:** The Illinois Audubon Society was founded in 1897 and is based in Springfield, Illinois. The Illinois Audubon Society is a non-profit organization and is Illinois' oldest non-profit

independent conservation organization. The society currently has 18 chapters throughout Illinois, and their mission is to “promote the perpetuation and appreciation of native plants and animals and the habitats that support them.”

**Scope and Content:** The contents of this collection are part of the institutional records of the Chicago Academy of Sciences. Content includes the by-laws of the Illinois Audubon Society; articles and newspaper clippings about birds and bird conservation; miscellaneous letters and announcements to and from the Illinois Audubon Society; letters and requests about publications from the Illinois Audubon Society; Letters between Illinois Audubon Society members; bills and receipts for the Illinois Audubon Society; Illinois Audubon Society financial statements; letters and lists regarding the Junior Audubon Society; Illinois Audubon Society meeting minutes; Illinois Audubon Society membership information; publications collected by the Illinois Audubon Society; announcements regarding Illinois Audubon Society activity; Illinois Audubon Society buttons; information regarding the “Checklist of the Birds of Illinois”, which was published by the Illinois Audubon Society; letters regarding a stamp collecting project related to the Illinois Audubon Society; and copies of the Illinois Audubon Society Magazine.
